Therefore, some points in the manuscript should be revised and corrected to proceed with the review process and probably, a consideration by this journal. See my comments below that avoid the manuscript acceptance at this moment.</p> <p>1 – Since this is an Asian journal, the authors should describe where is Kisangani geographically to the readers. Because it is not on Asia, and it is on Africa continent. Please insert line number to perform a good peer review of your manuscript.</p> <p>2- Please, check misspelling, typos, even in the abbreviations. Sometimes, the disease is called Covid-19 or COVID-19, please make a pattern. How many hospitals were involved in this research? Please clarify that in the abstract section and M&M.</p> <p>3- The number of cases and deaths from COVID-19 changes all the time, please provide a date of your numbers on the Introduction section.</p> <p>4- Is it KAP or CAP? What is DRC? Please, clarify all abbreviations in the first mention in the text, since they are used in the other parts subsequently.</p> <p>5- Please provide the coordinates of the hospitals (latitude and longitude), as well as if they were reorganized to attend COVID-19 patients.</p> <p>6- Ethical aspects – the authors did not provide an Institutional Review Board number that shows the study was approval. Please, you should have that, as well as the questionnaire used. See the author's guidelines in the journal "All manuscripts which deal with the study of human subjects must be accompanied by Institutional Review Board (IRB) or Ethical Committee Approval, or the national or regional equivalent. The name of the Board or Committee giving approval and the study number assigned must accompany the submission. If required, the author should be ready to submit a scanned copy of the IRB or Ethical Committee Approval at any stage of publication (Pre or post publication stage)."</p> <p>7- The discussion section is divided, please see the author's guidelines in the journal website. It is very confuse and need to organize before a submission to a peer review.</p>
