Consequently, the results derived from this study have significant implications for practical applications because the three investigated samples could be valuable natural preservatives. Moreover, the significant antioxidant of the seeds is an indication that it could be useful in the management of diseases due to oxidative stress, and obesity.</p> <p>In Conclusion section, please, make more clearly, the sentence: "In which natural plant products which have shown to be useful in protecting food against fungal infection and consequent mycotoxin production were shown to retard fungal growth in this study." Maybe is better: "The results of this study revealed that the natural plant products which have shown to be useful in protecting food against fungal infection and consequent mycotoxin production, were proved to retard fungal growth in this study."</p> <p>Also, please be more exact in the sentence "The significant antioxidant of the seeds is an indication that....." "The significant level of antioxidants (or the significant antioxidant potential) of the seeds is an indication that"</p> <p>The manuscript has been written in a standard English Nevertheless, I recommend a carefully check of the full manuscript to correct any grammatical error or syntax errors. In conclusion, I recommend the publishing of this paper.</p>
