Similarly- Vitamin D supplement in patients with other cardiovascular diseases, Vitamin D supplement in diabetic patients, Vitamin D supplement in patient suffered from osteoporosis, Vitamin D supplement in patient suffered from neurological or psychiatric disorders, Vitamin D supplement in patient suffered from thyroid diseases Generally, a heading should not contain full stop. Same thing happens in case of titles of the tables.
